mutual covenants and stipulations set out herein, agree as follows:

- 2. The total cost of the transfer will be determined by the cost of application divided by all water users included in the application packet. You will be notified when the application is accepted the total transfer cost & remaining balance/credit due.
- 3. The water user agrees to pay the charges determined by the district at the completion of the application.
- 4. A \$650.00 deposit is required upon the execution of this agreement. The balance is payable at the time a statement is rendered by the District upon the completion of the application.
- 5. The balance will be added to the water user's account at the conclusion of the application, water will not be delivered until the balance/account is paid in full.
- 6. If payment is not made as agreed, buyer promises and agrees to pay to the District reasonable attorney fees and collection costs, even though no suit or action is filed. In case suit or action is instituted on this contract, or to enforce any of the terms and conditions hereof, then and in such event the prevailing party shall be entitled to receive, in addition to the usual costs and disbursements, such sums as the Court may adjudge reasonable as attorney fees in said suit or action.
